



Instructions for Compilation and Despatch

1. A War Diary is SECRET.

2. The War Diary takes the place of the Historical Record when on active service. (K.R. Can. Para. 1530). Its objects are: to supply authentic material for the history of the unit, and of the force; to furnish a historical record of operations; and to provide data upon which to base improvements in training, equipment, organization and administration.

3. Unless otherwise ordered, the original and duplicate copies are sent on the first day of the succeeding month, through the usual channels, to the A.G., 2nd Echelon, wherever that office may be. The triplicate copy may be held by the unit for three months and then forwarded, also through the usual channels, to A.G., 2nd Echelon.

- 4. Post-war disposal will be as under:
 - Original—retained at Ottawa for historical purposes.
 - Duplicate—to British Record Office for historical purposes.

Triplicate-to unit for custody with unit records.

5. The War Diary will be entered up daily on M.F.M. 11 and rendered monthly in triplicate (Mobn. Instr. for C.M. 1937. App. "C"). Each entry will be initialled by the officer detailed to keep the War Diary, which will be signed at the end of each month by the commander. (F.S.R. Vol. II, Sec. 35, para. 3 iii).

6. The following should be recorded daily as events occur:

- (i) Important orders, instructions, reports, messages or despatches received and issued, and decisions taken. Original documents should be attached as appendices to the Original copy of the War Diary.
- (ii) Daily map location, employment, movements and dispositions of unit headquarters and of batteries, companies, etc. March tables should be attached as appendices.
- (iii) Important movements of officers and matters relating to the duties of each branch of the staff. A complete set of the *routine orders* and instructions, Part I Orders, issued by the unit during the month should be attached as an appendix to the original copy.
- (iv) Detailed account of operations-to include:-Exact hour, location and circumstances of important occurrences. Movements and names of neighbouring units. Commanders of batteries, companies, etc., names of Officers and number of O.R. (i) engaged and (ii) battle casualties. Dispositions, activities and identity of enemy forces. Prisoners and trophies captured. Ammunition expended. Factors affecting operations, topo-graphical and climatic. Maps and sketches showing dispositions of batteries, companies etc., at important phases. The record of communications, both written and verbal, received or despatched during active operations as an appendix. A complete set of the operation orders and instructions issued during the month. Notes on conferences and reports rendered to higher formations, or received from lower formations, as appendices to the original copy.

- (v) Nature and description of trenches, field works or accommodation occupied or constructed. Meteorological notes.
- (vi) Changes in establishment or strength. Names and ranks of officers and number of O.R. Attachment of units and individuals. Reinforcements. Copy of Part II Orders and Weekly Field Returns of Officers and O.R. should be attached as appendices to the original copy. Changes in organization, stores, transport, etc.

7. It is essential that all copies of both text and appendices are legible. Appendices will be numbered and referenced to the text in the last column of the form. Current issues of any regimental publication should be attached.

8. It will be found convenient at the end of each month, when the War Diary is being completed and the correspondence in unit files for the month is being reviewed and distributed (F.S.R. Vol. I, sec. 171, para. 3) if the material considered to be of historical value in the light of the above is attached as appendices to the original copy of the War Diary.

9. A good war diary makes possible the accurate and detailed reconstruction of circumstances, conditions and action.

NOTE: If monthly diary is more than one inch thick, use a second folder. If appendices are bulky, tie folder up with tape or string to make a firm package.

UNIT OFFICE FILING SYSTEM AND RECORDS

"Every office will arrange for the filing and custody of its own correspondence." (F.S.R. Vol. I. Sec. 171.3.)

1. Titles and Numbering of Files.

A simple filing system adaptable for use in any military office at home or in the field is illustrated by the "List of File Titles" overleaf.

All documents handled by a unit fall into one or other of the nine categories enumerated, 1 to 9. The titles of the nine main divisions are based on British army operations, organization, administration and the regulations governing. Each title may be broken down into ten component parts or sub-titles, by adding a dash and subsidiary numbers 0 to 9. In turn each of these may be further broken down by adding a second dash and a third digit, and if necessary a third dash and a fourth digit. Thus 4-7-3 might be "Cooking Course at Kingston." According to circumstances, a fighting unit would expand the 1-3 prefix to accommodate all arms and services with which it may be concerned

2. Date reference.

In giving communications a reference number, it is convenient to use the date system of four figures indicating day and month, e.g. 0102 for 1st February; 3010 for 30th October.

3. Combined Numeration.

If the systems outlined in paras 1 and 2 are combined, by placing the four date figures under the subject file numbers, a simple and informative method of reference results, thus

might be immediately identified as a communication dealing with replacement of gas masks, dated 8th April.

NOTE.—This method is not applicable to signal messages, A.F.C. 2128, which bear serial numbers 1 to 9999. The use of dashes eliminates confusion between serial numbers and file numbers.

4. Documents for Preservation.

The monthly review of correspondence (F.S.R. Vol. I, sec. 171.3) is facilitated and future confusion avoided by jacketing the material in "Category ii" (i.e., "no longer required", etc.) to conform with the system.

5. Correspondence in the Field.

The functioning of the office of a formation or unit during active operations may be simplified by keeping a log or register of all orders and messages, written or verbal, received or sent during the action. This may conveniently be done by extending the use of the "Field Register of Communications Received or Despatched", (Army Form 2040, F.S.R. Vol. I. sec. 171) to include verbal as well as written orders and messages in chronological order as received or sent. Time of sending and of receipt are of importance second only to time of event, and should be entered both on the office copy of every field message or other document, and in the log or register. A carbon copy for contemporary reference of the commander or others concerned is desirable.

A brief précis of written orders, reports and messages, with the sender's number, is sufficient, for they will be kept on file. But particular care is necessary in making entries of times of moves and of verbal orders, reports or conversations, by telephone or otherwise, which in the stress of action, may not otherwise be recorded on paper. In battle, operations messages dealt with by one officer may number over twenty-five per hour for several hours on end.

The record should be kept convenient to the telephone. Entries may be made by a clerk, or by the officer on duty at the telephone.

Such a record is invaluable to the commander in making appreciations of the situation during the action, and in compiling his report on the action afterwards. It is contemporary evidence of the highest quality, and therefore is of the highest historical value, and should be attached as an appendix to the original copy of the War Diary, together with the original documents sent and received.

1050—SECURITY OF OFFICIAL INFORMATION—(S)

All members of a HQ including all signal operators, signal office personnel, and drivers of HQ cars are reminded that they are employed in a position of trust and are therefore under an obligation of secrecy. They will make it a definite rule NOT to mention any phase of their work to any person nor to discuss any phase of their work with another member of the staff when there is any possibility of being overheard. Particular discretion will be observed when talking on the telephone. Members of a HQ will NOT communicate confidential or secret information to other members of the staff unless it is necessary for the proper performance of their duties. All personnel referred to above will read Overseas RO 1050 and familiarize themselves with the relevant extracts from the Official Secrets Act.

1089—SECURITY MEASURES—PRIVATE CORRESPONDENCE

The following regulations for the contents and transmission of correspondence shall apply to the private correspondence of personnel of the Canadian Army Overseas.

1. Allusions to any of the following matters are forbidden at all times in private correspondence during a war, whether relating to naval, military, or air forces or operations: —

- (a) Strength, moral or physical state, or organization of any of His Majesty's or Allied Forces, including any comment on the absence or presence in the United Kingdom or any theatre of war of a unit or formation to which any unit is attached or belongs.
- (b) Location or movement of any naval, military, or air force units or detachments, arrival or lack of reinforcements.
- (c) Armament or equipment of any kind.
- (d) Distinguishing signs used for the identification of formations, units, and their transport.
- (e) Communications—such as the use, condition or probable extensions of roads, railways, or other transportation facilities, bridging operations, etc.
- (f) Plans and forecasts or orders for future operations, whether known or merely rumoured or surmised.
- (g) State of the maintenance services, including any reference to reserves.
- (h) Position or description of barracks, billets, bivouacs, camps, training areas or schools.
- (i) Casualties before official publication.
- (j) Effect of any action by the enemy. Any remarks which might tend, if published, to encourage the enemy, to cause despondency in our own forces or people, or to incite a feeling of hostility among the people, in the theatre of war or in neutral countries.
- (k) Criticisms and statements calculated to bring into disrepute our forces or those of our allies.

2. Private correspondence will be in plain language. Codes, ciphers and shorthand are forbidden. It is forbidden either in the address or text of correspondence to connect the name of a place with that of a unit, or the name of a unit with the designation of an army post office.

- 3. Picture post-cards of the following categories will not be used: --
 - (a) Those disclosing the writer's present or past location, or the route by which movements of the writer's unit have taken place.
 - (b) Any aircraft of which photographs have not been published in the press.
 - (c) Any coast lines or silhouettes which might be easily identifiable and reveal the positions of aerodromes, defences and factories.
 - (d) Any factories (aircraft or otherwise) which have been built since 1 Sep 39.
- 4. It is forbidden to send, or to attempt to send, to unauthorized persons: --
 - (a) Official documents, including intelligence summaries, orders, reports, maps, etc, or to disclose their contents except in the course of duty.

(b) Any documents captured from the enemy, or found in places occupied by the enemy, and any documents containing information about the enemy.

(c) Any official documents belonging to the civil authorities in allied or enemy territory.

It is forbidden to communicate to the Press except through the duly authorized channel (KR (Can) 417, 433 and 434).

6. It is forbidden to send through the post photographs or films except those permitted by proper authority (Overseas RO 2430). It is forbidden to despatch to neutral or enemy countries photographs or pictorial matter of any kind, from whatever source they may have been obtained.

It is forbidden to insert advertisements or letters in any publication inviting correspondence 7. with strangers, or to enter into correspondence with any stranger in response to such advertise-ments or invitations. The greatest caution and reserve are necessary in acknowledging presents from unknown donors, or in replying to trade circulars from unknown merchants and dealers, especially those in neutral countries.

It is forbidden to make use of the civil postal services outside of the United Kingdom, or therein when the Army Postal Service is available, or to transmit correspondence by the hand of an officer, soldier, or civilian, proceeding outside the United Kingdom or a theatre of operation, except by a recognized military messenger service. Attention is directed to Overseas RO 3550.

9. Attention is directed to KR (Can) 410, 411, 1099 and 1491. In respect of disciplinary action in this connection attention is directed to Army Act, Secs 5 (4) and footnotes, 11 and 36.

2425-GRENADES-No. 68-ACCIDENTS WITH-(S)

1 Serious accidents have occurred when practice has been carried out with live No. 68 grenades.

Technical trials have proven that these have been caused by incorrect insertion of the 2. grenade into the discharger cup.

These accidents may be avoided if the No. 68 grenade is loaded into the discharger cup in the manner laid down in Small Arms Training, Volume I, Pamphlet No. 13 (1942), Lesson 4, para 5 (i).

Severe disciplinary action will be taken in future cases of negligence. 4.

2430—PHOTOGRAPHY—CONTROL

(As amended by Overseas RO 3571)

It is notified for information that para 5 of Defence Regulations provides that no officer or other rank shall, unless acting in the course of duty in His Majesty's service, make any photograph of, or of any part of, any object :-

- (a) In any such area in the United Kingdom as may be specified by order of a competent authority, being an area in relation to which the restriction of photography appears to that competent authority to be expedient in the interests of the defence of the realm, or
- (b) in any prohibited place within the meaning of the Official Secrets Act, 1911, MML, page 895, as amended by the Official Secrets Act, 1920, MML, page 900, that is:--
 - (i) Any work of defence, arsenal, navy, military or air force establishment or station, factory, dockyard, mine, minefield, camp, ship or aircraft belonging to or occupied by or on behalf of His Majesty, or any telegraph, telephone, wireless or signal station, or office so belonging or occupied, and any place belonging to or occupied by or an behalf of His Majesty and used for the purpose of building, repairing, making or storing any munitions of war, or any sketches, plans, models, or documents relating thereto, or for the purpose of getting any metals, oil, or minerals of use in time of war;
 - (ii) any place not belonging to His Majesty where any munitions of war or any sketches, models, plans or documents relating thereto are being made, repaired, gotten or stored under contract with, or with any person on behalf of, His Majesty, or otherwise on behalf of His Majesty; and

- (iii) any place belonging to or used for the purpose of His Majesty which is for the time being declared by order of a Secretary of State to be a prohibited place for the purposes of this section on the ground that information with respect thereto, or damage thereto, would be useful to an enemy; and
- (iv) any railway, road, way or channel, or other means of communication by land or water (including any works or structures being part thereof or connected therewith), or any place used for gas, water, or electricity works or other works for purposes of a public character, or any place where any munitions of war, or any sketches, models, plans or documents relating thereto, are being made, repaired or stored otherwise than on behalf of His Majesty which is for the time being declared by order of a Secretary of State to be a prohibited place for the purposes of this section, on the ground that information with respect thereto, or the destruction or obstruction thereof, or interference therewith, would be useful to an enemy.

2. It is to be noted that military hospitals, headquarters, barracks, billets, camps and quarters are included in the above-mentioned definition of prohibited places.

3. Officers and other ranks, except when they are acting in the performance of their duty, shall not take any photograph of the following subjects as enumerated in para 1 of the Control of Photograph Order (No. 1), 1939. The term duty shall be strictly interpreted by Commanding Officers. The taking of so-called "Unit record pictures" for War Diary or other purposes shall not be regarded as a matter of "duty" except for the official accredited military photographers on establishments of formation headquarters. Control of Photography Order (No. 1), 1939, enumerates the following subjects: —

- (a) Any fortification, battery, searchlight, listening-post or other work of defence.
- (b) Any aerodrome or seaplane station.
- (c) Any assembly of any of His Majesty's forces or any force to which the Allied Forces Act 1940 applies.
- (d) Any barracks, encampment or building occupied or in course of preparation for occupation by any of His Majesty's forces or any force to which the Allied Forces Act 1940 applies.
- (e) Any arsenal, factory, magazine or stores for munitions of war, arms, equipment or supplies for any of His Majesty's forces or of any force to which the Allied Forces Act 1940 applies, whether completed or in course of construction.
- (ee) Any munitions of war, arms, equipment, supplies or stores belonging to or intended for the use of any of His Majesty's forces or of any force to which the Allied Forces Act 1940 applies.
- (f) Any wireless, telegraph, telephone, signal or cable station.
- (g) Any dock, caisson, dockyard, harbour, ship-building works or loading pier.
- (h) Any vessel of war either complete or under construction, or any vessel or vehicle engaged in the transport of supplies or personnel.
- (i) Any aircraft or the wreckage of any aircraft.
- (j) Any building structure, vessel or other object damaged by enemy action.
- (k) Any hospital or station at which casualties, whether civil or otherwise are treated; any ambulance or convoy of injured persons, or any injured person.
- (1) Any electricity, gas or water works, or any gasometer or reservoir, or any oil store.
- (m) Any assembly of persons for the purpose of transport or evacuation, or any temporary camp or other accommodation or transport vehicles used for the purpose of evacuation.
- (n) Any riotous or disorderly assembly, or premises, or other objects damaged in the course of such an assembly.
- (o) Any roads or railways exclusively connected with works of defence.

4. Where it is desired to obtain, for unit records, photographs of subjects enumerated in para 1, Control of Photography Order (No. 1), 1939, as above, applications shall be made to the Public Relations Officer of the formation concerned for the services of an official military photographer.

5. Any photograph or photographic negative or photographic film which any officer, soldier, attached civilian or employee of the Canadian Army Overseas desires to send out of the UK will be contained in an envelope or wrapper plainly marked "photograph".

6. Registration of Cameras.—All ranks in possession of cameras will register them with the headquarters of the formation or unit to which they are attached. It will be the responsibility of formation and unit commanders that a list of all ranks in possession of cameras is maintained in their headquarters.

3658—TRAINING—RECOGNITION OF CONTAINERS CHARGED WITH WAR GASES

1. A number of accidents have occurred through failure to recognize containers charged with war gases which are issued for training purposes.

War gases used for training purposes may be contained in either of the following:-

(a) Metal containers painted grey all over and marked with a coloured band or bands.

(b) Stoneware bottles marked with a yellow or black band.

3. Such containers will be used or opened only under the supervision of an officer or NCO who has qualified at the Army Gas School or No. 6 (CW) Wing, CTS. This does not apply to generators lachrymatory, as instructions for using these are already given in Gas Training, 1942.

3659—TRAINING—SMOKE GENERATORS—USE IN CONFINED SPACES

-3659

1. Irritation of the throat and chest may be caused by screening smokes, but concentrations encountered in the open rarely cause ill-effects, and no restriction of normal training in the use of smoke is contemplated or is necessary. Concentrations at short distances down wind of a generator or grenade, or in confined spaces, may be harmful and inside buildings may even be fatal.

2. Smoke generators and smoke grenades of all types will never be functioned or used within confined spaces or buildings.

3. If affected by smoke or forced to remain for more than short periods in high concentrations, personnel should wear respirators, all types of which give full protection.

3703—AMMUNITION AND EXPLOSIVES—TAMPERING AND UNAUTHORIZED —3703 USE

1. Recent instances of serious or fatal accidents have occurred with 2'' mortar ammunition. These accidents not only deprive the Army of personnel, but have a tendency to destroy confidence in the 2'' mortar.

2. Recent investigations and Courts of Inquiry indicate that these accidents with 2" mortar bombs, as well as other types of explosives, are due to instructors stripping fuzes for information or instructional purposes and then placing the fuze back in the bomb in a fully armed condition, because it is difficult to return the fuze mechanism to the unarmed state.

3. It is brought to the notice of all ranks that it is strictly forbidden to tamper with ammunition or explosives at any time, or to use them in such a manner as to be contrary to regulations and instructions governing their use.

4. IOOs and AEs will carry out such tests and inspections and make reports on ammunition and explosives as may be authorized from time to time.

5. All cases of ammunition and explosives being of doubtful serviceability will be referred to the IOO of the formation for decision and disposal instructions. The destroying of such doubtful stores will be carried out under the supervision of an IOO.

6. All "Blinds" will be dealt with in accordance with the provisions of para 2 of Overseas RO 3125.

7. All accidents of an explosive nature will be reported and action taken in accordance with Overseas RO 3167 and 3236.

3790—SMALL ARMS—DAMAGE TO PROJECTORS, INFANTRY, ANTI-TANK, —3790 DURING TRAINING

1. Damage to cocking rods and rear-end caps of projectors, infantry, anti-tank, is constantly occurring during training due to careless cocking and uncocking.

2. The correct methods of cocking and uncocking are laid down in Small Arms Training, Volume I, Pamphlet No. 24, 1943, Lesson I. The weapon will never be uncocked by simply pressing the trigger.

3. Stripping, other than that authorized in Small Arms Training, will be carried out by armourers only.

3898—IDENTIFICATION CARDS

1. In the event of loss of identification cards MF M182 now being issued to all ranks of the Cdn Army Overseas, the fact of loss will be reported by the OC the unit direct to the OIC Records, CMHQ, with particulars as to rank, surname and full Christian name of officers, and

regimental number, rank, surname and full Christian name of ORs in addition to the date, place and circumstances of loss.

2. Should the circumstances surrounding the loss be of a suspicious nature or involve a breach of Security, copy of letter reporting loss to OIC Records will be forwarded direct to CMHQ (MI).

3. The OIC Records will report all losses of identification cards to Cdn Army Identification Bureau, NDHQ, through the proper channels on a request for replacement. When identification cards are received as replacements for lost cards, the OIC Records will distribute such cards in accordance with the provisions of Overseas RO 3130.

4. All ranks will carry identification cards MF M182 at all times after they have been issued. ORs will produce their identification cards for inspection at every pay parade. Personnel in possession of AF B2606 will continue to carry it in addition to MF M182. ORs will also continue to carry MB M1, Part I.

5. COs will in all cases investigate the loss of identification cards and, in those cases where the circumstances reveal neglect on the part of the holder, appropriate disciplinary action will be taken.

1302-DEPENDENTS' ALLOWANCE AND ASSIGNED PAY-SOLDIERS SENTENCED TO LONG TERMS OF DETENTION, IMPRISONMENT, OR PENAL SERVITUDE

Articles 90 and 91 FR & I (Canada), made applicable overseas by Articles 688 and 689 FR & I (Overseas), in their original form provided that a soldier's assignment of pay would be continued in all circumstances as long as dependents' allowance issued in connection with such assignments was paid to the soldier's dependents, subject to the reduction of such assignment to \$20.00 per month in the circumstances set out therein. Under such provisions, payment of assigned pay and dependents' allowance was continued in payment during a period of detention, field punishment or imprisonment, irrespective of the term of the sentence awarded.

2. The regulations in this respect have now been amended to provide that, when a soldier has been sentenced to a term of detention, imprisonment or penal servitude for a period of six months or more, the payment of dependents' allowance and assigned pay shall cease at the expiration of six months from the date of sentence, provided that, if the soldier is discharged from the Canadian Army prior to the expiration of such six months period, dependents' allowance and assigned pay will cease as at the date of discharge.

1451—PRESERVATION OF GAME—DISCIPLINE

1. The attention of unit commanders is again drawn to the necessity for warning all ranks against poaching and trespassing. Reports are being received that troops are wandering about, accompanied by dogs, over farms and private property.

To preserve good relations with local inhabitants, unit commanders will take steps to warn all ranks against the practice of wandering over farms, or leaving gates open, or interfering with pheasant or partridge nests in the coming spring.

Immediate steps will be taken by unit commanders to hand over to the civil police stray dogs which attach themselves to troops and which are unlicensed.

Disciplinary action will be taken in all cases in which poaching is discovered to have involved the use of firearms of any description.

2364-FIRES AMONG CROPS, PLANTATIONS AND WOODLANDS-ACTION TO BE TAKEN BY TROOPS-(S)

When troops see outbreaks of fire among crops, heathlands, woodlands, etc, it is their duty to assist in extinguishing them by any available means. It is essential that prompt organized action by trampling or beating out incipient outbreaks of fire be taken to prevent the fire from spreading. The greatest care must be exercised in the disposal of lighted cigarette ends, bottles and broken glass, which are potential causes of fire in open country, particularly in dry weather.

2710-DISCIPLINE-COMPLAINTS AND SUGGESTIONS

1. Any officer who wishes to put forward any complaint or suggestion will do so in writing to his commanding officer through the adjutant. If he wishes, he may request that a complaint be referred by his commanding officer to appropriate higher authority. (KR (Can) para 417, AA Sec 42.)

Any soldier who wishes to put forward any complaint or suggestion will do so to his com-2 2. Any soluter who wishes to put forward any compraint or suggestion will do so to his com-pany (or equivalent) commander. If, after the matter has been investigated by his company (or equivalent) commander, he is not satisfied, he may represent it through his company (or equivalent) commander to his commanding officer. If he is still not satisfied, he may represent it through his commanding officer to the GOC-in-C, First Canadian Army, or the Senior Officer, Canadian Military Headquarters, as may be appropriate. (KR (Can) para 417, AA Sec 43.)

3. In addition, an officer or soldier who wishes to bring any grievance to the notice of an inspecting officer may do so through his adjutant in the case of an officer, or through his company (or equivalent) commander in the case of a soldier. All grievances will be investigated and settled, if possible by the commanding officer. Any grievance which the commanding officer is unable to settle will be included in a tabulated return prepared for the information and use of the inspecting officer. (KR (Can) paras 73 and 418.)

The above procedure is that laid down in the Army Act and KR (Can). Its object is to 4. ensure that any representations officers and other ranks wish to make are effectively dealt with in the most expeditious way possible, and that proper discipline in the Army is maintained. Any other method of putting forward complaints or suggestions, such as anonymous representations, or combined petitions, is expressly forbidden by KR (Can) vide paras 417(c) and 419.

2711-CASUALTIES-NOTIFICATION TO NEXT-OF-KIN-(S)

In order to avoid giving false information to next-of-kin, all ranks will under no circumstances pass on any information regarding casualties. Letters and cables of condolence may be sent but only after a sufficient lapse of time to permit the next-of-kin to receive the official notification.

2760-DISCIPLINE-LOOTING AND DAMAGE TO PROPERTY-(S)

This Order states that needless damage to billets and requisitioned property, and the removal and looting of private property from houses entered for defence purposes will be regarded as serious offences. The Defence (General) Regulations, 1939, provide that a person who steals from premises which have been subjected to attack by the enemy, whether by aircraft or other-wise, shall be liable to suffer death or penal servitude for life. All cases of looting by persons subject to military law will be tried by GCM unless they have been prosecuted in the Civil Courts.

The Order does not prohibit free sharing of cigarettes and tobacco with others in the Cdn Armed Forces nor distribution by COs to the troops. 3215-LEGAL AID

1. The need for a legal aid scheme for soldiers serving in the Canadian Army Overseas has become increasingly apparent. In addition to giving legal advice to soldiers in the United Kingdom, a plan has been devised whereby through the courtesy of the Canadian Bar Association, legal assistance will be furnished, in certain classes of cases, to personnel of the Canadian Army Overseas by members of the legal profession in Canada.

This aid is available only in respect to civil legal problems, and is not applicable in disciplin-2 ary action, criminal offences, or in any matters, such as pay and allowances, which can be dealt with through other channels. The function of this scheme is advisory as to the legal solution and necessary action. The conduct of litigation will not be undertaken by officers rendering aid. The expense of any action taken by the soldier on such advice is to be borne by him.

3. It is also to be clearly understood by all ranks seeking and acting on such legal aid that any advice or assistance rendered is given and received on the condition that the recipient has no right to compensation against either the Crown or the officer or other person giving the same for any loss or damage suffered as a consequence of any negligence in or arising out of the giving of that advice or assistance.

In order that a soldier who requires legal advice may have his case disposed of expeditiously, and in appropriate cases forwarded to Canada for attention by the Canadian Bar Association, the following action will be taken forthwith :-

- (a) Legal Aid Bureaux will be formed at all formation headquarters and will be under the direction of the legal officer appropriate to that formation.
- (b) Such Bureaux will consist of a panel of regimental officers selected from serving solicitors, where possible one officer from each unit of the formation. While service on the panel is on a voluntary basis, it is expected that all serving solicitors will offer their assistance.
- (c) The panel of serving solicitors will be maintained by the formation legal officer and he will notify commanding officers of units, and each member of the panel, of the names and units of the serving solicitors comprising the panel.

5. Personnel desiring legal advice may be given permission to consult any of the serving solici-tors on their respective formation panels. Commanding officers will ensure that every facility is afforded to personnel desiring advice so that they may receive such advice with the least possible delay.

The intention behind the Legal Aid scheme is that soldiers will be able to obtain private legal advice on confidential matters: It is therefore contrary to the intention for commanding officers to insist that the officers rendering such legal aid should disclose to them what transpires in the Legal Aid Bureau, in the sense that the details of the cases, in which advice is given to soldiers of their units, should be made known. It cannot be too strongly emphasized that the assistance given to a soldier over his private affairs is kept entirely as a confidential matter between the soldier concerned and his adviser.

Detailed instructions for the guidance of formation legal officers and serving solicitors will be issued separately in Pamphlet form.

3275—PENSION ACT—APPLICATION

1. It is notified for information that in respect of members of the military forces serving out-side Canada, pensions are awarded under the Pension Act when the injury or disease, or aggravation thereof, resulting in disability or death was attributable to or was incurred during military service.- No pension can be awarded when disability was due to improper conduct, except that in such cases the Pension Commission may, when the applicant is without earnings or income sufficient to provide maintenance, award such pension as it deems fit in the circumstances.

The Pension Act defines "improper conduct" as including wilful disobedience of orders, wilful self-inflicted wounding and vicious or criminal conduct. (Ref RO (Can) 2843)

3313-CHANGE OF ADDRESS-NEXT-OF-KIN

1. It is essential to draw to the attention of all ranks the necessity for the maintenance of an up-to-date record of next-of-kin.

2. All ranks are reminded that, in the interests of themselves and of their next-of-kin, it is their duty to report to their COs without delay any change in the name, address or relationship of their next-of-kin. Changes thus reported will be notified to OIC Records in unit Part II Orders.

The recording of particular individuals as next-of-kin has no legal effect whatever as regards the distribution of property in the event of death.

Personnel should advise those whom they have named as their next-of-kin that they too should report promptly any change in address, as under :-

3322-TRANSPORTATION TO CANADA FOR DEPENDENTS OF MEMBERS -3322 OF THE CANADIAN ARMY OVERSEAS

- (a) The Canadian Government has authorized free minimum cost ocean and rail transporta-1. tion, except in the United States, to destination in Canada, for wives, widows, and children under 18 years of age (hereinafter called "dependents") of members of the Canadian Army Overseas (hereinafter called "members"). Dependents who travel via the USA will pay their own rail fare from port of arrival to the Canadian Border which is recoverable in whole or in part after arrival in Canada to the extent allowed by the regulations in force from time to time. (For information about refunds see para 8 of this Order.)
 - (b) Higher class ocean and Canadian rail transportation, may be secured if available, upon payment in advance of the difference in cost.
 - (c) Sleeping car accommodation, meals on shore and gratuities on ship or on shore, are not paid by the Canadian Government.

The provision of transportation (and refunds where such are granted) as described in this Order, is retroactive to the outbreak of war.

3 Transportation will be subject to shipping restrictions. Normally accommodation will not be available for dependents on the same ship with members.

4. The provision of transportation is subject to the granting of "Exit Permits" by the UK authorities. Dependents who do not possess "Canadian domicile" acquired by residence in Canada, are subject to Canadian Immigration regulations on entering Canada.

5. Transportation will be provided for one journey only to Canada for any dependent. All dependents, 16 years of age or over, will be required before sailing, to declare their intention to take up permanent residence in Canada. After arrival in Canada they will not be given Canadian Exit Permits to return to Britain while the war continues, and if any succeed in returning by other means, they will not become eligible for free transportation a second time.

Normally a dependent (other than one having "Canadian domicile"-as defined in para 4), will not be eligible for free transportation until the member is returning to Canada for discharge or some other permanent purpose. No exception to this general policy will be made unless settlement arrangements in Canada have first been approved by Canadian Immigration authorities.

Application for transportation and inquiries in connection therewith, should be made direct to the Canadian Commissioner of Emigration, Sackville House, 40 Piccadilly, London, W1.

Application for refund-(a) by dependents who returned to Canada at their own cost, before this scheme of free transportation came into effect; and (b) by those who may be given refund of USA rail fare as mentioned in 1 (a) of this Order, should be made direct to the Immigration Branch, Department of Mines and Resources, Ottawa. Refund at minimum rates will be made only to dependents in Canada.

3364-TREATMENT OF ENEMY PRISONERS OF WAR ON CAPTURE

1. It is desirable that all ranks should be aware of the general principles which should govern the treatment of enemy prisoners of war, with particular reference to their treatment immediately after capture.

The treatment of prisoners of war is governed by the International Convention relative to the treatment of Prisoners of War (Geneva 1929) printed as Amendment 13 (January, 1936) to the Manual of Military Law.

3. The Convention provides in Article 2 that "Prisoners of War are in the power of hostile Government but not of the individuals or formation which captured them. They shall at all times be humanely treated and protected particularly against acts of violence, from insults and from public curiosity. Measures of reprisal against them are forbidden."

In Article 3 it is laid down that prisoners of war are entitled to respect for their persons 4. and honour.

5. Instructions as to the treatment of prisoners of war are contained in Field Service Regulations, 1930, Vol I, Section 126, para 7, as follows:—

"It should be noted that Prisoners of War are frequently captured in an exhausted condition though unwounded. In these circumstances examination will not yield results, and for that reason as well as for reasons of humanity arrangements should be made for supplying food and drink to such prisoners as are manifestly in need of stimulation on their arrival in divisional collecting posts."

6. The treatment of prisoners of war will be in accordance with the above principles. Care should be taken to see that when interrogated the prisoner of war is in a fit condition to answer questions. His treatment from time of capture and during interrogation should be firm and fair. He should be given food and drink at regular intervals and if he is wounded, every care should be taken to see that he receives the same treatment as Canadian troops. There should, however, be no fraternization with a prisoner of war.

7. It should be borne in mind that special care must be taken to preserve any documents which the prisoner of war may have in his possession.

8. It will be appreciated that it is the duty of a prisoner of war during operations, to escape or to impede his capture if he can do so. It is equally every soldier's duty to prevent with such force as may be necessary, any such action by a prisoner of war who may be in his keeping during operations. The treatment of prisoners of war in the battlefield will, however, always have regard to the principles set out in paras 2, 3, 4, 5 and 6 above.

9. Only when special circumstances of a particular occasion make the binding of a prisoner while still on the battlefield imperative and when there is no feasible alternative will such measures be adopted, and then only so long as such special conditions exist.

10. The general binding of prisoners of war is strictly forbidden.(Pef ACI 266 of 43) (45/Treat)

3427—OCTU—APPLICATION BY INDIVIDUAL SOLDIERS

-3427

A. GENERAL

1. In conformity with the policy in effect in Canada, permission is granted for any soldier serving in the ranks of the Cdn Army Overseas to make application for OCTU.

2. This in no way relieves the CO of his responsibility for seeking out and recommending for OCTU all men now serving in the ranks whom he considers to possess the necessary qualifications. Junior officers will be encouraged to bring to notice the name of any man who might be considered for eventual commissioning, and when men who are fitted to hold commissioned rank are not earmarked as prospective OCTU candidates it is evidence of failure to co-operate in one of the essential needs of the war effort. Recommendations for OCTU will be accepted at any time.

3. A new application form (CMHQ 1000:11b—obtainable from No. 1 P & S Det, RCASC) will be taken into use immediately for all OCTU candidates. When a soldier desires to make application for OCTU he will be furnished by his CO with this application form. The applicant will complete the form in part, in his own handwriting. The CO will then interview the applicant and will forward the application to CMHQ. Such applications will not receive priority over those already on file at CMHQ.

4. A CO in forwarding an application may request deferment for a period not exceeding three months in order that he may more adequately assess the candidate, or to permit applications to be completed for candidates already under consideration by the Unit Selection Board.

5. In the event that it comes to the notice of higher authority, through Selection of Personnel Section, Records, or other sources, that an individual serving in the ranks has, apparently, the necessary education and intelligence, an enquiry may be directed to his CO asking whether it is proposed to recommend him for OCTU. If the reply is in the negative, instructions may be issued for the soldier to be interrogated by his CO to determine whether he desires to apply for a commission. If so, his application will be forwarded to CMHQ.

B. QUALIFICATIONS

6. Long and faithful service is not to be regarded as sufficient qualification. Before making application, the soldier should carefully consider to what degree he possesses the following qualifications and characteristics on all of which he will be carefully assessed.

- (a) Power of leadership.—A leader must inspire confidence. To do so he must possess better than average intelligence, endurance, judgment.
- (b) Personality-Ability to approach, to attract and to influence others.
- (c) Appearance-A soldierly and confident bearing at all times.
- (d) Initiative-Ability to originate and improvise.
- (e) Reliability—Trustworthiness in every respect including a reputation for carrying out willingly, speedily and efficiently, any appointed task.
- (f) Habits-A way of life and thought. Loyal, co-operative, temperate.
- (g) Conduct-A clean record or clear evidence that past indiscretions will not be repeated.
- (h) Knowledge of arm-Better than average.

- (i) Education—Junior matriculation is not essential, but education should approximate that standard. The requirements of RCA, RCE and RCCS necessitate a knowledge of mathematics approximating matriculation standards. Every opportunity for candidates to refresh on educational subjects will be provided at the Pre-OCTU School and deserving candidates whose education is below standard will be given special attention and consideration. Applicants for OCTU should prepare for the Pre-OCTU School by individual study. Particulars of the requirements of the school may be obtained from unit Educational Officers.
- (j) Experience—Normally at least six months experience in a field unit or formation is expected. Service as an NCO is desirable but will not be insisted upon if a candidate has clearly demonstrated qualities of leadership. A candidate may apply for commissioning in another arm if his educational, civilian and military experience make him suitable for training in that arm. A soldier possessing technical qualifications should apply for commissioning in the arm where his knowledge will be of greatest value to the army generally.

C. PROCEDURE

7. When a soldier desires to make application for consideration by the OCTU Selection Board, he will apply to his CO for OCTU application form (CMHQ 1000:11b). The applicant will complete this form in Part "A" in his own handwriting.

- 8. The CO will then interview the applicant and will : -
 - (a) Recommend him for consideration by the OCTU Selection Board, or
 - (b) request the OCTU Selection Board to defer the recommendation for a period not exceeding three months, or
 - (c) recommend the candidate as unsuitable for consideration by the OCTU Selection Board. The CO will set forth in full in the application, his reasons for considering the candidate unsuitable.

9. COs will, under no circumstances, withhold applications from individual soldiers and all applications must be forwarded without delay to CMHQ.

10. In cases where the applicant receives the recommendation of the CO he will be brought before the OCTU Selection Board.

11. When the applicant fails to receive the recommendation of the CO, the OCTU Selection Board will consider the candidate's qualifications as disclosed by the application and will determine whether or not an interview will be granted.

12. Candidates must have their "Q" cards completed and have taken the "M" test prior to appearing before the OCTU Selection Board. The CO will endeavour to arrange the necessary interview with a representative of the Selection of Personnel Section, but failure to do so should not delay the application being forwarded. If necessary, CMHQ will assume responsibility for completion of the "Q" card and "M" test.

3437—VENEREAL DISEASE—DEFENCE REGULATION 33B

1. A Defence Regulation (33B) has been passed in order to check the spread of venereal disease.

2. The Regulation applies to men and women in the Services and civilians alike and provides that, if there is good reason to believe that any person has been spreading venereal disease, that person may be compelled to be examined and, if necessary treated for it. This system will only work if anyone suffering from the disease reports to a medical officer the name and address or any other particulars of identity of the person from whom it is believed to have been contracted.

3. Any member of the Cdn Army who undergoes treatment for venereal disease is urged to make the fullest disclosure to the medical officer of the facts or suspicions as to the source of the infection in order that the spread of venereal disease may be controlled and reduced.

4. This does not lead to the person whose name is so reported being punished in any way. It only means that that person will be called upon to be examined and if necessary, treated, if some one else sends in (or has already sent in) a similar report about her (or him).

5. The information given in such a case is treated as confidential. The person named in the report will not be told who made the report. No legal or other liability attaches to those who report a person's name provided they do it in good faith, believing that what they say is true.

3648—PAYMENT OF CANADIAN PERSONNEL PRIOR TO DESPATCH TO BRITISH SCHOOLS

In all cases where OR personnel are being despatched from units for the purpose of attending courses of instruction or training attachments, they will be paraded to the unit paymaster, who will make suitable advances of earned pay and/or traveling or subsistence allowances, where applicable, in accordance with existing CMHQ Pay Instructions.

1. It is apparent that the type of assistance available under the Legal Aid Scheme, Overseas RO 3215, requires clarification. It is still the duty of Regimental Officers, Paymasters, Medical Officers, Chaplains and Auxiliary Service Officers to give prompt assistance to any soldier seeking advice with regard to his personal problems.

2. Commanding Officers, Chaplains and all Officers or Auxiliary Service Supervisors, dealing with cases of cessation of normal domestic relations, or temporary estrangement between husband and wife, should, in all cases, strive to effect a reconciliation and to prevent a home being broken up on account of a temporary estrangement or for insufficient cause.

3. In order that the soldier's personal problems may be dealt with expeditiously, multiplicity of effort on the part of those assisting the soldier avoided, and, so far as possible, the institution of more than one enquiry into the soldier's affairs at the same time eliminated, such problems will be dealt with as set out hereunder: —

- (a) Unit Officers, Chaplains and Auxiliary Service Supervisors will give such advice and assistance as lies within their power (subject to the reservation that unqualified persons shall not attempt to give legal advice). If the problem is such that for some reason it is not one that the advice and assistance which can be given by Unit Officers, Chaplains and Auxiliary Service Supervisors will bring the soldier's problem to a satisfactory conclusion, it will be dealt with as hereinafter noted.
- (b) All questions primarily affecting the soldier's pay, including AP and DA, shall be referred to the Unit Paymaster who will deal with them through normal pay channels.
- (c) Personal problems of the soldier, other than those covered by sub-paras (a), (b) and (d) which are causing him worry and cannot be dealt with in the field, for example cases in which he is worried over home conditions and merely wants investigation of the same, shall be referred to Canadian Military Headquarters (attn: AAG (Pers)) as follows:—
 - (i) Units on a Field Return basis through Cdn Sec, GHQ, 2nd Echelon, to Canadian Military Headquarters.
 - (ii) Units on a Part II Order basis, direct to Canadian Military Headquarters.
- (d) All civil legal aid matters on which legal advice is required including domestic relations cases in which legal action is to be taken or is contemplated, shall be referred to Legal Aid Officers as provided in Overseas RO 3215 and the Legal Aid pamphlet referred to therein.

4. The soldier shall have the right to insist that his purely personal problems be not dealt with through official channels. Such cases shall be handled as in the past without reference to Canadian Military Headquarters (AAG(Pers)). Officers giving assistance will ensure that the soldier's problems are not already the subject of an official investigation.

5. Officers from whom soldiers seek advice will ensure that their problems are dealt with through the proper channel. Doubtful cases should be submitted to Canadian Military Head-quarters, as in para 3(e), (i) and (ii) above.

- 6. It should be made clear to the soldier that: --
 - (a) Disclosure of his purely personal problems will not prejudice him in his capacity as a soldier in securing promotion to which he is entitled or otherwise.
 - (b) His affairs, when dealt with through official channels, will be handled in a confidential manner, and will not be brought to the notice of anyone who is not immediately concerned.

7. It is particularly important, in the interests of both the soldier and the Service, that certain types of cases be dealt with through official channels from the start, e.g., cases which are likely to involve application for compassionate return to Canada, in regard to which official investigation in Canada is essential before action may be taken overseas.

3741—INCREASES OF PAY—PRIVATE SOLDIERS—CDN ARMY, ACTIVE (As amended by Overseas RO 3851)

1. Overseas RO 3271 and 3472 are hereby cancelled.

2. With reference to Article 144 FR & I, increases of pay to private soldiers will be granted under the conditions set out hereunder: —

(a) *First Increase*—After 4 months continuous service with the Active Army, a soldier will be eligible for an increase of pay from \$1.30 to \$1.40 per diem, provided that during the immediate previous four months period:—

EFFICIENCY

(i) He has reached a state of efficiency which might reasonably be expected in conformity with opportunities for training available to him, has performed his duties satisfactorily, and the Officer Commanding his unit certifies that these conditions have been met.

CONDUCT

- (ii) He has not forfeited pay and allowances under Article 149 of FR & I (Canada) or Article 683(2) of FR & I (Overseas) in excess of an amount equal to three days pay, or
- (iii) He has not been awarded fines which in the aggregate exceed an amount equal to three days pay, or
- (iv) The total of forfeitures and fines under (ii) and (iii) above is not in excess of an amount equal to three days pay.
- (b) Second Increase—After 6 months continuous service in the Active Army, a soldier will be eligible for an increase of pay from \$1.40 to \$1.50 per diem provided:—

PROFICIENCY

- (i) He has attained a degree of proficiency in training applicable to his Arm or Corps which ought to be reached two months after receipt of the first increase and the Officer Commanding his unit certifies that this condition has been met.
- (ii) He fulfills the conditions as defined in sub-para (a) (ii) (iii) or (iv) above, during the two months period following the first increase.

3. Soldiers with 6 or more months continuous service who, at the date of qualifying under para 2(b) (i) have not been in receipt of the first increase of pay, may, at that time, be granted the second increase provided during the immediate six months period they have qualified under para 2(a).

4. A WO or NCO reduced or reverted to the rank of Private will be eligible for increased rates of pay, from the date of reduction or reversion, provided at that date, he has fulfilled the conditions under para 2(a) and (b). Otherwise, he must qualify under para 2(a) or (b) as the case may be. The rate to which such WO or NCO is entitled must be published in Part II Orders.

1. In future all re-testing or re-mustering of tradesmen in the UK will be carried out by the Trade Testing Boards under the direction of the President, Trade Testing Board, HQ, CRU, in accordance with existing procedure, or in the case of the CFC, by the Trade Testing Boards authorized for that corps.

3867—PARACHUTE BADGE

1. A parachute qualification badge is hereby authorized to be worn by officers and other ranks of the Cdn Army Overseas under the conditions set forth below.

- 2. (a) The description of the badge is as follows:-
 - "Between outspread wings, an open parachute. Superimposed upon the base of the suspension lines, a maple leaf."
 - (b) The badge will be worn on the left breast $\frac{1}{4}$ inch above the flap of the blouse, Service dress or khaki drill jacket. The badge will be worn $\frac{1}{4}$ inch above medal ribands where applicable.
- 3. (a) To qualify for the badge, officers and other ranks must have made eight jumps and reached the prescribed standard at a qualifying course.
 - (b) The badges may be worn by qualified personnel throughout their service unless the badge is forfeited.
- 4. The Parachute Badge will be forfeited in the event of a qualified parachutist: ----
 - (a) Refusing to make a parachute jump when ordered to do so in the course of his duties; or
 - (b) Wilfully absenting himself without leave when a parachute jumping parade has been ordered with intent to avoid such parade; or
 - (c) On ceasing to be employed as a parachutist as a result of misconduct while doing duty with Airborne troops.

5. The Parachute Badge may be restored after a period of not less than three months from the date of forfeiture provided the officer or other rank has again qualified as in para 3 above since the date of forfeiture.

6. A parachutist who before qualifying injures himself in a jump from an aircraft in flight or captive balloon, in such a way as to preclude further training as a parachutist, may at the discretion of the OC unit where training was being carried out, be authorized to wear the Cdn Parachute Badge.

7. The grant, forfeiture and restoration of Parachute Badges will be published in Part II Orders.

8. Personnel awarded the badge in Canada are not required to requalify hereunder.

5. When military exigencies require, all books will be recalled to unit HQ and transported by the Library Van Service to the appropriate formation HQ where the formation Education Officer will take charge.

1. When personnel are to be transported for any considerable distance in army vehicles where seating accommodation does not form part of the vehicle, forms will, whenever possible be provided as seats. When no seating is provided, personnel will sit on the floor.

2. The practice of sitting on the sides of vehicles is prohibited. Under no circumstances must personnel ride on the tail board. When the vehicle is in motion, the tail board must be closed and properly secured.

1442—GUNS, MACHINE, BREN .303-in, MARK I— USE OF SEPARATED CASES WITH CLEARING PLUGS

1. Cases have come to light whereby damage is being caused to the barrel face of Bren guns due to the incorrect use of the clearing plug during training.

2. Such damage will only occur where no separated case is present and the clearing plug is inserted loosely in the bottom of the chamber.

3. On no account will clearing plugs be used without the separated cases. These cases can either be inserted in the chamber with the aid of a drill cartridge, or placed over the clearing plug itself.

4. Separated cases for this purpose should be prepared by unit armourers.

2087—WASTE PAPER AND CARDBOARD AND MATERIALS MADE THEREFROM—(S)

1. The following Order issued by the Ministry of Supply, is published for the information of all concerned:-

"1. (i) No person shall, except under the authority of and in accordance with a licence granted or a special or general direction issued by the Minister of Supply,

- (a) destroy any waste paper (except for the purpose of preventing the spreading of any infectious or contagious disease, or for the purpose of saving property from immediate danger of destruction or damage whether by fire or otherwise),
- (b) throw out or abandon any waste paper otherwise than by making it available for collection in accordance with the system of collection in operation in the district,
- (c) dispose of any waste paper otherwise than to a British or Canadian Army Salvage Depot,
- (d) put any waste paper in a refuse bin or other receptacle for refuse, or
- (e) mix any waste paper with any material or article not being waste paper."

2. The foregoing Order is applicable to and binding on personnel of the Canadian Army in the United Kingdom.

3. The salvage of all waste paper, as defined in the Order above quoted, is of vital importance. In future such waste paper will not be burned or otherwise destroyed, and none will be thrown away elsewhere than into the receptacles provided for such waste paper. Disobedience of this Order will be treated as a disciplinary offence. Security and Confidential documents will be disposed of as provided in Overseas RO 3897.

2089—PETROL AND LUBRICANTS—CARRIAGE OF ON CANADIAN ARMY VEHICLES

1. The carriage of spare petrol, oil and water on all MT vehicles (other than "A" vehicles and ambulances) belonging to the Canadian Army Overseas, is forbidden at all times other than when vehicles are engaged in active operations or higher training exercises, or when authorized by a Divisional Commander or higher as being an advisable or necessary occasion.

2. Ambulance cars will not normally be required to carry spare petrol, oil and water, but they may do so at the discretion of local commanders, when stationed at isolated places.

3. Containers for the carriage of spare petrol, oil and water, will be held under unit arrangements until receipt of "Stand To" order when they will be issued to vehicles.

4. Petrol, oil and other inflammable liquids will NOT be carried in the interior of coaches, troop-carrying vehicles or load-carrying lorries, when carrying troops.

5. Smoking on or near vehicles carrying inflammable liquids is hereby prohibited.

2127—SMALL ARMS—CARE AND PRESERVATION

1. An increasing number of small arms and weapons, especially rifles, are becoming unserviceable through causes other than fair wear and tear. It is of vital importance that weapons be maintained in a serviceable condition at all times.

2. Commanding Officers will impress upon personnel under their command the importance of proper care in the preservation of small arms.

3. Commanding Officers will be held financially responsible for damage to small arms where the damage is due to causes other than fair wear and tear. (KR (Can), Para 37—Art 682, FR & I (O).)

2202—PURCHASE OF FOOD AND TOBACCO BY TROOPS ON THE MARCH

1. Instances have arisen recently where troops on the march, on being halted in villages, have been permitted to fall out and purchase food and tobacco in the village shops, with the result that no supplies are available for the inhabitants.

2. In such cases, the troops, who are provided with adequate rations and who have further provision made in the canteens run by NAAFI and Auxiliary Service Organizations, are buying and consuming the limited supplies available for the civilian population.

3. Conduct of this nature is not only a breach of march discipline but is also calculated to damage the good feeling which should exist between the Army and the civilian population.

4. Os C will ensure that when on the march or in convoy, troops are forbidden to fall out for the purpose of entering the shops of any town or village in which they may be halted.

2315—CIVILIANS—CARRYING OF IN CANADIAN ARMY VEHICLES

(As amended by Overseas RO 2438, 3209 and 3510)

- 1. Civilians will not be carried in Canadian military vehicles, except as permitted under: --
 - (a) Para 3 hereof (in respect of civilians performing duties or rendering services in the interests of the Canadian Army Services).
 - (b) "MT Drivers' Regulations, Canadian Army Overseas."

- (a) Except as provided in para 3 hereof, the officer, NCO or other rank authorizing the carriage of any civilian in a Canadian military vehicle will in every case, prior to the commencement of the journey, obtain a release in respect of that journey on Form Can F ST 1073A, signed by each such civilian personally. Prior to the signing of such release, the said officer, NCO or other rank will ensure that such civilian understands the meaning of the form which he or she is signing.
 - (b) Chapter 2, para 44 of the pamphlet "MT Drivers' Regulations, Canadian Army Overseas", authorized by Overseas RO 3510, headed RECREATIONAL USE.
 - (c) A separate release will be required for each journey provided that a journey may consist of a round trip, i.e., to destination and return; and provided further that the same form may be signed by more than one civilian if each civilian's signature is witnessed as above required.
 - (d) Other than persons referred to in para 3 hereof, no civilian will be carried in any Canadian military vehicle unless he or she has first signed a release as provided for in this para. This requirement may not be waived under any circumstances.
 - (e) The CO (or officer acting for him in his absence) who is authorizing the journey will either complete Vehicle Release Form Can F ST 1073 or endorse the Transport Work Ticket (AF G3518), prior to the commencement of any recreational journey within the provisions of the orders referred to in para 1(b) hereof.
- (a) Where reasonably necessary under the circumstances in any particular case, civilians may be conveyed in Canadian military vehicles for the purpose of performing duties or rendering services in the interests of the Canadian Army Overseas. No release will be required in any such case.
 - (b) Transportation is authorized for entertainers (other than members of the Canadian Forces) engaged under the direction of the Auxiliary Services Organizations, or any of them, to appear in performances or entertainments for Canadian troops. Provided, however, that before transporting any such persons in Canadian military vehicles the officer furnishing such transportation shall require the production by such person of a certificate of identity signed by the Assistant Director of Auxiliary Services, Canadian Military Headquarters.

4. Commanding Officers will ensure that the above is brought particularly to the attention of all personnel concerned with the control, allotment and operation of military transport.

2572—RATIONED FOODSTUFFS—ARMY RATIONS—PURCHASING AND TRADING IN—(S)

1. Instances have occurred of units having purchased nationally rationed foodstuffs from sources other than NAAFI and exchanging Army rations for non-rationed foodstuffs.

2. These practices are contrary to the instructions contained in Overseas RO 2466 and 3176 and deprive the local civilian population of its proper share of rationed foods.

3. Rationed foodstuffs will not be purchased from the messing cash allowance or by messes from any source other than NAAFI, to whom quantities of certain rationed foods are released periodically for sale to messes.

4. Army rations are Government property and will not, under any circumstances, be disposed of by sale, gift or barter. If a unit or mess builds up a surplus of any particular item, underdrawal will subsequently be made in order to eliminate the surplus.

2614—UNSERVICEABLE VEHICLES

In order to prevent accidents and the development of defects, any vehicle not mechanically fit will be taken out of service immediately and will not be used until the necessary repairs have been effected.

2640—LAMPS, BRAZING—USE

(As amended by Overseas RO 3041)

1. Accidents (one fatal) have occurred as the direct result of petrol being used in a brazing lamp.

2. Lamps, brazing (VAOS, Section "F"), except FA2469 lamps, brazing, $\frac{1}{2}$ -pint, which is a petrol-burning lamp, and lamps, blow, brazing (VAOS, Section LV 6—MT 2, and VMS for MT, MT Section 2) are designed to use paraffin (or kerosene), and petrol must *NOT* be used in them. (Ref ACI 1971 of 42) (13/Prov F/1/2)

3115-BOTTLES, WATER-CARE

1. Investigation has shown that the rusting of the metal components of the water bottle stoppers is due to carelessness on the part of the individual. To obviate this fault, the following routine will be carried out after parades or exercises, etc, where the water bottle is used:—

- (a) The water bottle will be emptied of its contents and inverted in such a manner that air can circulate inside.
- (b) The cork and all metal components will be thoroughly dried to prevent deterioration and rust.

3315—"A" AND "B" VEHICLES—ENGINE GOVERNORS

1. The engines of some "A" and "B" vehicles are fitted with a governor, the function of which is to limit the engine speed to a safe maximum and thus prevent damage from excessive revolutions; it is not designed to limit the power developed by the engine or to cut down the road speed to comply with traffic regulations.

In spite of repeated instructions on the subject of governors, engines continue to be returned for heavy repairs made necessary through damage directly attributable to irresponsible tampering with governors.

The only persons having authority to check, adjust and seal engine governors on "A" and "B" vehicles are the following:—EMEs, RCOC or their representatives, OsIC RCASC Workshop Platoons, inspection officers of the MT Inspectorate, or a representative of the manufacturers.

4. The following instructions will be observed by all concerned : --

- (a) Drivers of vehicles will be instructed that the governor seals on vehicles must not be tampered with in any circumstances and that, in the process of cleaning the engine, etc, care must be taken to avoid damaging seals or sealing wires.
- (b) Every driver taking over or handing over a vehicle, no matter for how short a period, will satisfy himself that the governor seal is intact. If it is not intact he will report the matter immediately.
- (c) Officers concerned with the care and maintenance of vehicles will examine the governor seals at every inspection and at frequent surprise inspections.

5 Immediate disciplinary action will be taken in cases in which the above instructions are disregarded.

3510-MT DRIVERS' REGULATIONS, CANADIAN ARMY OVERSEAS

A revised edition of the pamphlet "MT Drivers' Regulations" is hereby authorized under the title of "MT Drivers' Regulations, Canadian Army Overseas".

An initial issue of this revised pamphlet will be made direct to formations without indent on the basis of one pamphlet per vehicle, plus one copy for every officer and NCO.

The instructions contained in this revised pamphlet will be followed by all ranks. Particular attention is called to the note on the front cover as follows:-

"This pamphlet must be carried at all times by drivers of Canadian Army Vehicles em-ployed as such and will be returned to the MT Officer when such driver leaves the Unit or ceases to be employed as a driver. It must be produced on the order of a Superior Officer, and on all kit and other inspections."

To prevent confusion and to conform to the accepted British method of expressing tonnage figures in Long Tons, future references by individuals, units or depots when making consignments by rail or application for shipping space for Cdn military equipment, will be made on basis of 2240 lbs per ton.

3603—COOKERS, PORTABLE—PRECAUTIONS TO BE TAKEN

A case has come to notice of costly damage to unit equipment, resulting from the cleaning 1. and lighting of a portable cooker in a confined space.

The modification to this equipment laid down in OER B.257 is designed to reduce the necessity for frequent cleaning, and will, therefore, reduce the fire hazard. The instructions contained in this OER will be strictly observed.

3. Before lighting in a confined space, the cooker will be removed as far as possible from walls, tarpaulins or other inflammable objects, and care will be taken that no excess petrol is allowed to remain on cooker frame or surrounding space.

3624—TRAVELLING—ISSUE OF RAIL CONCESSION VOUCHERS TO HUSBANDS OF WOMEN SERVING WITH THE ARMY

1. Rail Concession Vouchers may be issued to husbands of women serving in the Cdn Army for the purpose of visiting ill or wounded wives in hospital.

2. This concession does not apply to cross channel journeys or to rail travel in Northern Ireland and/or Eire.

3. It is emphasized that this concession is restricted to hospital visits as mentioned in para 1 above.

3634—WRISTLET WATCHES, UNIT EQUIPMENT—CARE AND PRESERVATION —3634

1. With a view to ensuring that wristlet watches which are unit equipment remain waterproof as far as possible during use, it is essential that units should not remove the backs of watches. This will be done only in RCOC workshops when the articles are sent for repair.

2. It is impressed on all concerned that a watch must be taken off when the user is washing or bathing.

3. When winding, the user should be particularly careful to give the winding button a half turn backwards, i.e., towards 6 o'clock, immediately the operation of winding is completed.

4. When taken off and placed on a hard surface, care should be taken to ensure that the watch is laid face upwards. This will add to its life and avoid, to a great extent, the glass becoming scratched.

3651—VEHICLES—AVOIDANCE OF DAMAGE TO GPO PLANT AND CABLES —3651

1. Drivers of tracked and wheeled vehicles will be instructed to exercise the greatest care to avoid damage to Post Office line plant such as telegraph poles, telephone kiosks, cables and cable joint box covers.

2. Particular care will be exercised in the use of ground spikes for recovery operations in the vicinity of underground cables. These are laid, to a great extent, along road margins, and their existence is usually indicated by appropriate signs or by the presence of manhole covers and distribution poles at intervals along the routes of the cables.

3. Should damage inadvertently be caused to any GPO telecommunications plant, it is important that the Post Office authorities be advised at once. This can be done by telephoning to any Post Office exchange, asking for the supervisor and giving details of the location and, if possible, the general nature of the damage done. The rank, name and unit of the soldier reporting the damage will be given.

4. The action required by para 3 above is in addition to the compiling and forwarding of Road Accident Reports in all appropriate cases, as required by Overseas RO 2183 (1) (as amended by Overseas RO 3227).

3665—RAZOR BLADES—SUPPLY

1. Owing to restriction in manufacture in the UK, supplies of razor blades for the civilian population have been greatly curtailed.

2. Razor blades are available to all ranks under the provisions of Overseas RO 2131 and troops can normally obtain one blade a week from Service canteens.

3. Cdn Army personnel are not permitted to purchase blades from shopkeepers. Supplies in the shops are intended for the civilian population who have no other means of obtaining them.



- (ii) <u>Air Mail Letter Cards</u> (Blue Form), to CANADA, UK and USA ---- 3 d. On the form printed in UK postage required is stated to be 6d. This will be disregarded. The issue of AMLCs is rationed to one per man per week.
- (iii) <u>Airgraphs</u> 3d. Airgrpahs are not rationed, but will be sold at the FPO will stamps already affixed.
- (iv) <u>6¢ US Sea/Air Service</u> to CANADA and USA. Envelopes embossed with a 64 US stamp are on sale at FPOs. These are carried by sea to USA, thence by air.

(vi) Teler ms

Any Cdn or Brit MPO will accept EFM - Expeditionary Force Message. Lotter telegrams NLT or DLT.

(vii) EFM - only standard texts are permitted. The service is available to CANADA, UK and other countries but NOT to USA. The charge is 2/6 or local equivalent.

(viii]Letter Telegrams

DLTs are available to CANADA. The rates vary from 15/5 to the Maritimes to £1/1/10 to British Columbia.

NLTs are available to the UK. The rate is 8/4,

NLTs are available to the USA. The rates wary from 15/5 to the New England States to £1/1/10 to California.

These rates are for a message of 25 words or less, and the prefix address, text and name of the sender are chargable.

(ix) General Instrs for Telegrams

The full postal address of the adresses <u>MUST</u> be shown, and should be written in block capitals. It is compulsory for the senders <u>surname</u> to be included in the message to be telegraphed as the "Name From" but the sender may also include his christian name if he so desires. Both christian and surname <u>must</u> appear in the medsage to be telegraphed for telegrams to the USA.

The senders whit must not appear anywhere on the telegram form except when text No. 200 is used, but his number, rank name and corps, (ie - RCE, RCA, Inf etc) must be written at the foot of the form. This is not telegraphed and not charged for.

Telegrams will be accepted at the Sender's risk, and no enquiries concerning them will be undertaken.

All telegram services will be suspended from 6 Dec - 25 Dec.

(x) Censorship

Consorship is a unit responsibility. Officers and Mursing Sisters only are allowed to censor their own mail.

"Free Mail" and AMLCs will be handed to the censoring officer unsealed. The consoring officer will place his name at the foot of the message, and again in the lower left hand corner of the face of the envelope. In each case, the name <u>only</u> will appear, No rank will be shown.

The impression of the Unit censor stamp will also appear in the lower left hand corner of the free of the envelope.

"Green" envelopes will be issued on the scale of one per man per week. These may be used in two ways:-

(a) Contained one letter and forwarded to a private address.

(b) Containing up three letters and addressed "Base Cansor".

"Privilege" AIMCs will be issued once every four weeks in lieu of the regular ration. They bear a certificate similiar to that on the "Green envelope", which certificate will be signed by the sender.

"Green" envelopes to private or Base Censor adresses and "Privilege" AMLCs will be handed in sealed. They will NOT be censored within the Unit but will be stamped with the unit Censor Stamp and forwarded to the nearest FPO.

(xi) Addressing

The importance of notifying all correspondents of the correct form of address cannot be overstressed. Any officer or Other Rank on special duty or attachment, and who is in doubt of the correct form of address, should contact the nearest Postal Officer.

The sender's unit must NOT appear on the outside of any cover, nor will the unit orderly room stamp be used.

(Present stocks of blue air mail letter bearing triangle only maybe used for regular unit consored mail. All "green" envelope or AMLCs will be handed to coy censoring officer by soldier wishing to make use of this privilege).

(xii) Special Xmas Arrangements

The normal weekly ration of AMICs will be increased to two per week for the weeks ending 6, 13, 20, 27, Nov and 4 Dec. One of these AMLCs may be mailed each week free of postage. Such postage free AMLCs will have the word "Free" written by the sender in the top right hand corner. The Post Office will cake special arrangements for the delivery of these during Xmas week. Latest dates of posting for delivery before Xmas.

3. NOTES ON 426 FUZE 'PIAT" BOMB

3-4

The fuze 426 will function at 50° either by direct action against face hardened armour or by sudden retardation of the bomb. It will function on hard ground at 100 yds range. The splinter effect on water is very condiderable. The PIAT bomb has a fragment that is driven beck towards

the firer with great velocity, sufficient to kill at 125 yds. At ranges less than 250 yds, the firer and loader will be either prone or in s slit trench and will wear steel helmets. No tps or spectators will stand closer than 70 yds to the firer when engaging targets at short ranges. When used for high angles of fire at buildings etc, these precautions are not hecessary. Though the possibility of 'blinds' is greatly decreased

with fuze 426, these do occur frequently. On NO account must the bomb be touched, but must be destroyed in sity, taking all prec-autions against the splinter effect. A drop of 3 ins when the bomb is 'armed' will explode it.

Rough handling trials sho it is safe to carry with the fur fitted under all conditions of service to fwd posns.
